

Fund 50: Water

Fund Summary


Projects in the Water Fund address the Water Treatment Plant and all distribution related costs for the City's expanding customer base. Projects under **capital maintenance** are used for repairs and maintenance as needed to keep our assets in good working order, and those under **capital projects** are one-time expenditures that add new or greatly enhance City assets.

Revenues

Revenues for the Water Fund come primarily from fees collected from water users. Plant Investment Fees which are paid by developers to account for the increased burden of their development on the water system is the second largest share of projected revenues.

Expenditures

Many of the projects in the Water Fund are either moving through the procurement process or were recently awarded contracts in quarter one. Of note is the South Platte Well Transmission Line which began construction in quarter one along Bromley Lane. This project is currently 50% complete and is expected to be done in quarter two.

As part of the contract with the vendor a certain level of consistent reads is guaranteed. Staff is working with the vendor to ensure this level of reads is met before issuing that final payment.
502001	Municipal Service Center	\$ -		\$	368,865	Started	A design contract was just issued and the first design meeting was recently held. Design is expected to complete in mid-2022.
502005	Distribution Line Install	\$	1,634		\$ -	Complete	Final invoice for project was not received in time to hit 2020 budget. This invoice will be covered through savings in other projects.
502011	South Platte Well Transmission Line	\$	557,916	\$	3,990,690	Started	For water line replacement along Bromley Lane. This project is currently 50% complete and is expected to be done by the end of quarter two.
502012	Security Enhancements	\$	7,470	\$	730,000	Not Started	This project is currently being reprioritized. Construction projects across this and other funds are coming in higher than expected due to ballooning material costs nationally. The Utilities Department has delayed the start of this project until better information is available regarding actual costs for other projects in this fund. This project will be re-assessed at that time to determine the best course moving forward to maintain a balanced budget. Current spending is for unanticipated carryover of the EPA risk assessment from 2020.
502015	Water Treatment Plant Upgrade	\$	26,793	\$	11,000,000	Started	This project is currently at 30% drawings and will go before Council again in May with 100% of design completed as well as a request to release additional funds for equipment purchases.
502019	124th Reservoir Armoring	\$	2,996	\$	1,000,000	Not Started	The contract for this project was approved by Council in April and work is underway.
502023	Midland Outfall Weir Upgrades	\$	1,289	\$	25,000	Started	A contract for this project was recently signed and work is underway now. The project is expected to be completed by the end of July.

502102	Vehicle Replacement & Acquisition		\$ -	\$	79,645	Started	For planned replacements of fleet vehicles. Several vehicles have been ordered and are awaiting arrival. Due to COVID related supply chain issues, many vehicle manufacturers are expecting delays in shipment of vehicles. Due to this, it is possible that some vehicles will not be delivered until 2022, meaning they cannot be charged until 2022. The Budget & Performance Team is working closely with the Fleet Operations Supervisor to monitor these delays and address them in the 2022 Budget.
